- Green Jobs Coalition will be working with CEDS (Comprehensive Economic Development Strategy). \$60,000 grant received from the Federal Government around green economy and green jobs.
- Updated non-tidal and tidal flood insurance maps and required code amendments.
  These updates are part of standard re-evaluations done by FEMA periodically to assure the accuracy of the maps and the risks associated with flooding.
- Received a grant to update Baltimore's existing 'All Hazard Mitigation Plan' and, with approved FEMA funding, development of a more comprehensive All-Hazard Mitigation Plan to address changes in our flood maps.
- Introduction of Susan Carroll, new Program Coordinator for Baltimore Neighborhood Energy Challenge
- Annual Report coming along. Will be looking for assistance on Biodiversity goal, transportation, and green jobs. Also, will be asking Commissioners to assist with the "Steps You Can Take" section of Report. What would we like citizens to do to assist with achieving goals.
